## TERMS AND CONDITIONS

The following terms and conditions apply to your engagement of Krishnan Company for the preparation of your income tax returns. The words "client", "you" and "your" mean the Krishnan Company client(s) referenced on the invoice; "Company", "we", "us", and "our" mean Krishnan Company, P.C. CPA. By signing your tax return that contains our name in the tax preparer section, you are confirming your understanding of our mutual responsibilities and the terms and conditions of this engagement. Please review your tax return carefully before signing and transmission to the tax authorities.

1. Our fees indicated on the invoice are due and payable on receipt of the invoice.
2. Our services in preparing your tax returns are limited to tax return preparation only. Any tax advice, planning or consulting will be invoiced at the prevailing hourly rate.
3. We will prepare a federal and state(s) income tax return(s) solely based on information provided by you to us. It is your responsibility to provide to us all relevant documentation needed in the preparation of your tax returns.
4. You have the final responsibility for your tax returns and therefore you should carefully examine your tax returns before transmission to the tax authorities.
5. You are responsible for providing us all information necessary to recognize and identify (i) all states and foreign countries in which you "do business" or derive income (ii) the extent of business operations in each relevant state or country. We will use the information provided to apply any applicable credits, however you are responsible for meeting any foreign country income tax or country reporting requirements.
6. It is solely your responsibility to inform us if you directly or indirectly hold any interest in foreign assets, businesses located in a foreign country, or have signatory authority in any assets or financial accounts located in a foreign country. The information you provide will be used to calculate any applicable foreign tax credits. We will also use this data to inform you of any additional filing requirements, which may include FinCEN Form 114 Report of Foreign Bank and Financial Accounts (FBAR). Failure to comply with certain filing requirements can result in the imposition of both civil and criminal penalties, which can be significant. These are not tax returns and their preparation is not within the scope of this engagement. If you engage us to prepare these forms, we will delineate the additional charges for this service. As part of your federal income tax return, you are required to report the maximum value of specified foreign financial assets, which include financial accounts with foreign institutions and certain other foreign non-account investment assets that exceed certain thresholds. In some but not all cases, this filing obligation may overlap with your FBAR filing obligations, which is available upon request and will incur separate charges. You are responsible for informing us of all foreign investments so we can properly advise you as to your FBAR and income tax return filing obligations.
7. We may communicate by facsimile transmission, send electronic mail over the Internet or maintain client data in a secure electronic vault. Such communication and storage may include data that is confidential to Client. While Company will use its best efforts to keep such data and communication secure in accordance with Company's obligations under applicable laws and professional standards, Client recognizes and accepts that Company has no control over the unauthorized interception of such communication once they have been sent and consents to the use of such electronic media and communication during this engagement. Company will send such emails only to an email account provided by you. Client understands that it is Client's responsibility to update or inform Company of any changes to their email address. Client will hold Company harmless of any consequences arising from communication not received by Client due to invalid or outdated email addresses.
8. We will return the original hardcopy documents provided by you for the preparation of these returns. You are responsible to ensure that you have received all the original documentation back. If you are missing any original documents, you will inform us within one business day of receiving your prepared tax return.
9. You are responsible for retaining all the documentation, canceled checks and other data necessary to substantiate the information used in preparing your tax returns. By signing your return you agree to retain the records to substantiate all items of income and deductions. US Congress has greatly limited taxpayers' deductions for travel, gift and entertainment expenses. The minimal substantiation must include at least the amount of expense, the place of travel or entertainment, the date and description of the gift, the business purpose of the expense, the business relationship of the taxpayer and the entity receiving the entertainment or gift benefit.
10. You understand that we are not responsible for the taxing authority's disallowance of doubtful deductions or inadequately supported documentation, or for any resulting taxes, penalties, and interest.
11. Our work in connection with the preparation of your income tax returns does not include any procedures designed to discover errors, omissions, fraud or other irregularities, should any exist.
12. You are responsible for prior year tax returns not prepared by Company. In the event of any audits, amendments, associated notices and agency communication, such services will be invoiced as per our prevailing rate schedule under separate engagement.
13. Your returns may be selected for review by the taxing authorities. You have certain rights to appeal any levy or adjustments by the taxing authority. In the event of such examination we are available to represent you and render additional services in this connection. You understand that our current fees do not include any compensation for such services. Our fee also does not include charges for communication with the IRS or other agencies on your behalf. Such services will be invoiced at the prevailing hourly rate under separate engagement.
14. We will use our professional judgment in preparing your returns. Whenever we are aware that a possibly applicable tax law is unclear or that there are conflicting interpretations, we will adopt whatever position you request on your return, so long as it is consistent with the codes, regulations, and interpretations that have been promulgated. When possible we will resolve questions involving the application of such rules in your favor, if there is a reasonable justification for doing so. If the authorities were to later contest the position, there may be additional assessment of taxes, penalties and interest. We assume no liability for such additional taxes, penalties or assessments.
15. If you choose to file your returns electronically for faster refunds, you must review and sign the return before it can be transmitted. Once the taxing authorities accept the return, we are not responsible for the length of time it takes the authorities to process your return.
16. In our relationship, we are often advisors not advocates, with respect to investment advice. 19. If you choose to file your returns electronically, you hereby consent to the transmission of this information electronically and understand the inherent risks of such transmission.
20. We will use our judgment to resolve questions in your favor where the tax law is unclear or where there are conflicts between the taxing authorities' interpretation of the law and what seem to be other supportable positions. We reserve the right to disclose a position on a tax return where it is required of us by law. We will not provide you with a legal opinion on various tax positions. We can, however, advise you of the consequences of different positions. We will adopt your requested position on your applicable returns, provided, however, that such position is consistent with our professional standards and ethics, the determination of which is in our sole discretion. In the event that you ask us to take an unsupported tax position or refuse to make any required disclosures, we reserve the right to withdraw from our engagement with you without completing or delivering the tax returns. Any such withdrawal shall terminate our engagement, and you agree to pay our fees based upon time expended at our standard rates, plus all out-of-pocket expenses through the date of withdrawal.
21. In recognition of the relative risks and benefits of this agreement to both the client and the Company, you agree, to the fullest extent permitted by law, to limit our liability to you for any and all claims, losses, costs, damages of any nature whatsoever so that our total aggregate liability to you shall not exceed one times the total fee for services provided in the invoice.
